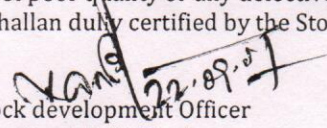

7. Payment will be made on receipt of bill in duplicate along with delivery Challan duly certified by the Store keeper, GL Store.

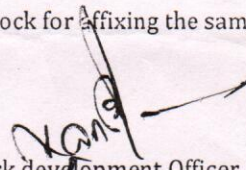
