

**MINUTES OF THE DISTRICT LEVEL REVENUE MEETING HELD ON
24.8.2016 AT 11.00 A.M in the CONFERENCE HALL OF D.M.,s OFFICE
GOMATI DISTRICT,UDAIPUR.**

Welcoming all the participants, the District Magistrate & Collector, Gomati District has initiated the discussion with the SDMs, present in the meeting and the following decisions were taken after threadbare discussion by the District Magistrate & Collector Gomati District.

1. **SMALL SAVINGS:-**The Collection position was reviewed in the meeting. and found not satisfactory. The point for successful implementation of the programme has been discussed as to how public in a large scale will be motivated. SDM, Amarpur requested for poster in the market areas for the purpose of propaganda as well as wide publicity. SDM Udaipur also requested to make them available leaflets. D.O Small Savings should arrange the materials as suggested, also directed to submit report in regard to the criteria's required to run NBFC. SDM Amarpur stated that he will find out the non-banking organization if any lies in Amarpur Sub-Division.

2. **SALES TAX:** - The performances of Sale Tax of this District have been reviewed in the meeting. The Supdt. of Taxes is directed to send his representative to accompany with the team during joint raid being conducted by the respective SDMs.

3. **Legal Metrology:** - Revenue Collection for the month of August, 2016 is Rs.71,625/-. However it has been again decided that Joint visit/raid should be conducted in the interior markets once in a week to locate as to whether packed goods like Water bottle, Cold drinks etc. are being sold in which date of expiry already over. The team comprising the representative of Sale Tax/Excise/Food/Legal Metrology under leadership of SDM /DC/DCM of the respective Sub-Division.

The SDMs are again requested to fix up suitable date of Joint inspection/raid with a copy to this Office and the team members should submit joint inspection report through the SDM concerned. The respective heads of line Departments are instructed to issue direction to their concerned field level Officers to accompany with the joint inspection team.
